KBS INFLATABLE KINGDOM TERMS AND CONDITIONS OF HIRE

It's the responsibility of the hirer to ensure that all possible steps are taken to avoid injury or damage to the inflatable/s. Please ensure that the following safety instructions are followed:

- 1) Please ensure no-one over the height stated on the website for each inflatable uses the equipment and that you follow the restriction listed on the front/step and user amount is not exceeded
- 2) No food/drink to be consumed on the inflatable (to avoid mess and choking)
- 3) All shoes, badges, jewellery (i.e., large earrings, necklaces etc.) MUST be removed. It is recommended that spectacles are also removed
- 4) No face painting, glitter tattoos, party poppers, coloured streamers or "silly string" must be used near or on the inflatable, as they can permanently stain the unit to which the cost of the repair or replacement would be charged to the hirer
- 5) NO smoking on or near the inflatable
- 6) During hot weather the inflatable can become hot so extra care must be taken but water must NOT be used under any circumstances
- 7) We recommend socks to be worn to prevent friction burns, full length clothing is also recommended
- 8) Climbing, hanging or sitting on the walls is VERY dangerous and must not be allowed
- 9) At least one responsible adult, over the age of 18, MUST supervise the inflatable at all times
- 10) Ensure that the inflatable is not overcrowded; limit the numbers depending on the age and size of the children. If children are colliding into each other then the unit is overcrowded. Maximum user number for each height group is listed on the front step
- 11) Try to avoid large children and small children using the inflatable at the same time
- 12) No pets to be allowed on the inflatable at any time
- 13) Do not allow anyone to bounce on the front step. The step is there to help users get on and off the unit. The safety matting provided at the front of the inflatable should be kept in place at all times.
- 14) Ensure no one with a history of back, neck problems or pregnant women use the inflatable/s. If anyone has any doubts, they should not use the inflatable/s
- 15) Do not allow users on the inflatable during inflation and deflation of the inflatables/s
- 16) In the event of rain/showers any wetness including bubbling can be dried easily with a towel. Wet inflatables will be slippery and more dangerous so it is advised the unit is dried before use and should NOT be used while raining.
- 17) In the case of strong winds or gusts all inflatables should not be used and immediately turned off. Any wind speed over force 5 on the Beaufort scale 30-38kph / 19-24 mph is classed as unsafe
- 18) Ensure the vent on the side of the blower is kept clear at all times
- 19) The inflatable MUST NOT be moved at any time, moving the inflatable will invalidate any liability on the part of KBS Inflatable Kingdom
- 20) Please ensure the inflatable is kept clean and any dirt is removed. There is a £30 cleaning charge for any unit left in an unacceptable condition
- 21) If you are unsure about anything please contact us before using the equipment
